- 2 All designations shall have the underlying zones of the zones in which they are located.

3 State Highways 1 and 82

The purpose of the "State Highway" designation is to give public notice of the existence of the work and the nature and extent of activities permitted pursuant to the designation.

The designation provides for the New Zealand Transport Agency, either itself or through its agents, to control, manage and improve the state highway network including planning, design, research, construction and maintenance relating to all land within the designation. Such activities may also involve, but not necessarily be limited to realigning the road, altering its physical configuration, culverts, bridges and associated protection works. Where appropriate, resource consents under the Resource Management Act 1991 will be applied for.

No other activity shall be permitted on the land designated "State Highway" without the express written approval of the requiring authority responsible for the designation and the appropriate statutory approvals.

In addition, as new works are proposed these may be designated, either under Section 181 or 168 of the Resource Management Act 1991, depending on the nature and scale of the work. A list of new works is set out below:

a) SH 1 Waituna Stream Bridge

This proposal is to extend the existing bridge and realign the approaches. The bridge is currently positioned on a curve which required easing within the existing speed environment.

b) SH82 Kurow Bridges Replacement

This proposal involves replacing the existing wooden bridges across the Waitaki River between Hakataramea and Kurow. The existing wooden bridges have reached the end of their economic life and will be replaced by 2 new concrete bridges downstream but as close as possible to the existing bridges.

c) SH82 Elephant Hill Stream Bridge

The Elephant Hill Stream Bridge is narrow and on a poor alignment, and is reaching the end of its economic life. The proposal is to construct a new two-lane bridge to the west of the existing one, realigning SH82 to improve approach alignment at the same time.

d) SH1 Glenavy North Passing Lanes

A potential site for a set of double-direction passing lanes has been identified on SH1 between Crowes Road and Cooneys Road.

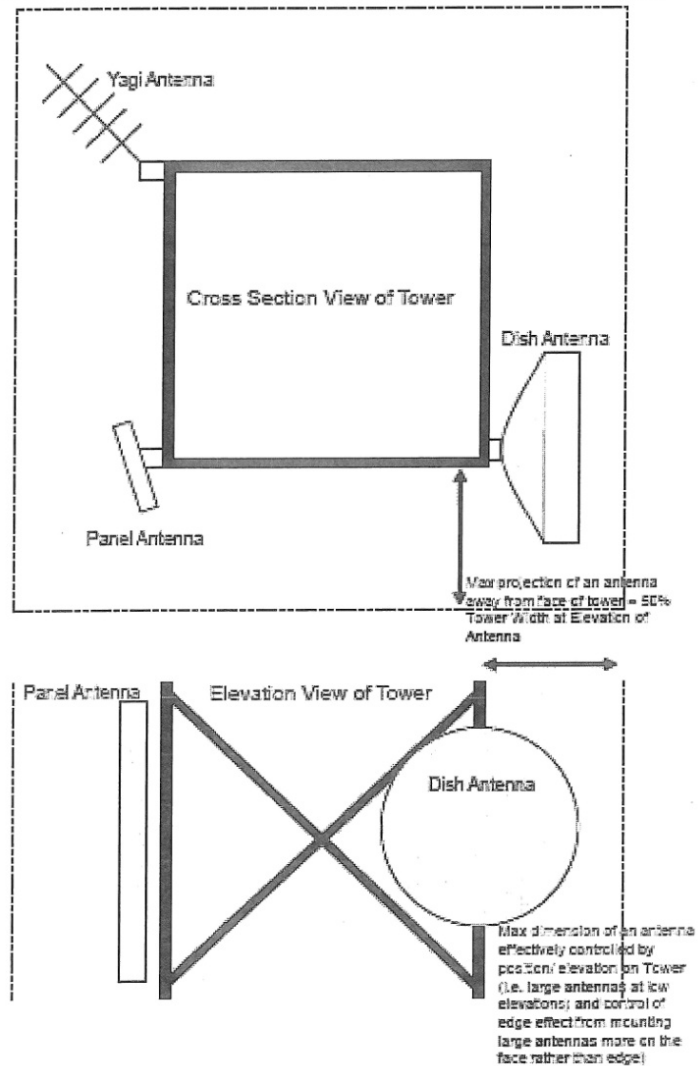
Designation 120 – Waimate Sewage Treatment and Disposal Facilities

- 1 The sewage treatment and disposal facilities shall be constructed and operated generally in accordance with the drawings and descriptions put forward in the Notice of Requirement, the applications for resource consents, the further information provided pursuant to section 92, and refinements put forward at the hearing on the 17 and 18 September 2001, except where otherwise required by conditions attached to the Designation or the consents. Specifically, the areas to be used for treatment ponds and effluent irrigation are limited to the areas shown on the plans. (held by Council)
- 2 The designation shall not include the bed of the Waimate Creek.
- 3 The plant shall be operated so as to minimise the use of the aerators on still nights when they could be audible from the nearest residence, consistent with operational requirements.
- 4 Contracts for the construction of the ponds and irrigation area shall include a requirement that the contractors water exposed ground if weather conditions create noticeable dust reaching any neighbouring residences.
- 5 Landscape planting, and possibly earth mounding, shall be provided along at least part of the north-western side of Horgans Road so as to completely screen the ponds and associated structures from the Dempsey residence (Lot 63 DP 844) as soon as practical. The adjoining plantation shall be managed so that the screening it provides is not eliminated until some other screening is in place.

Designation 33 – Kordia Limited

- 1 The Notice shall be given effect to in accordance with the requirement/application and assessment of effects on the environment prepared by Hey Consulting (Taupo) Ltd and Plans title 'Mt Studholm Tower Layout' being drawing number 19521-101 and 'Mt Studholm Site an Locality Plans' being drawing Ref 195421.10
- 2 An Outline Plan is not required for the addition and replacement of antennas on the existing tower provided the antenna including the mount, the shroud and dice shield, and ancillary equipment shall fit within the dimensions of a square shape in plan view that when measured from the centre of the tower, does not increase the effective visual width of the tower by more than 50% (see diagram below).
- 3 An Outline Plan is not required for the addition or replacement of antennas attached to or above the existing transmission building provided that:
 - (a) no gantry, pipe mount or antenna extends to an elevation greater than 3m above the roof line of the building
 - (b) no antenna measures greater than 3m in dimension
- 4 No new structures shall be erected on the site without submission of an Outline Plan of works pursuant to section 176A of the Resource Management Act 1991 other than the antennas set out in conditions 2 and 3 above.
- 5 Structures which are either intended to replace existing structures or any temporary structures erected for the purpose of allowing maintenance or repair of existing structures are permitted provided that any temporary or replaced structures are removed once any such replacement, maintenance or repair has been completed.
- 6 Only one telecommunication tower shall be on the site with a maximum height of 60.7m including any attachments. This excludes provision for a lighting rod.
- 7 Radio frequency radiation emissions from the site shall comply with NZS 2772.1:1999 Radio Frequency Fields (Maximum Exposure Levels – 3kHz to 300GHz).

Designations 21, 23 and 25, Chorus NZ Limited

1. The height of any new mast and antennas shall not exceed 15m.
2. Any equipment transmitting radiofrequency energy shall comply with the exposure levels stated in New Zealand Standard NZS2772.1:1999 at any place where the public has reasonable access

Designations 22, 24, 27, 28, 29, 30, 31 and 32, Chorus NZ Limited

1. The height of any new mast and antennas shall not exceed 25m.
2. Any equipment transmitting radiofrequency energy shall comply with the exposure levels stated in New Zealand Standard NZS2772.1:1999 at any place where the public has reasonable access

Designation 26, Chorus NZ Limited

1. The height of any new mast and antennas shall not exceed 35m.
2. Any equipment transmitting radiofrequency energy shall comply with the exposure levels stated in New Zealand Standard NZS2772.1:1999 at any place where the public has reasonable access

Designation 123, Telecom NZ Limited

1. The height of any new mast and antennas shall not exceed 25m
2. Any equipment transmitting radiofrequency energy shall comply with the exposure levels stated in New Zealand Standard NZS2772.1:1999 at any place where the public has reasonable access.
